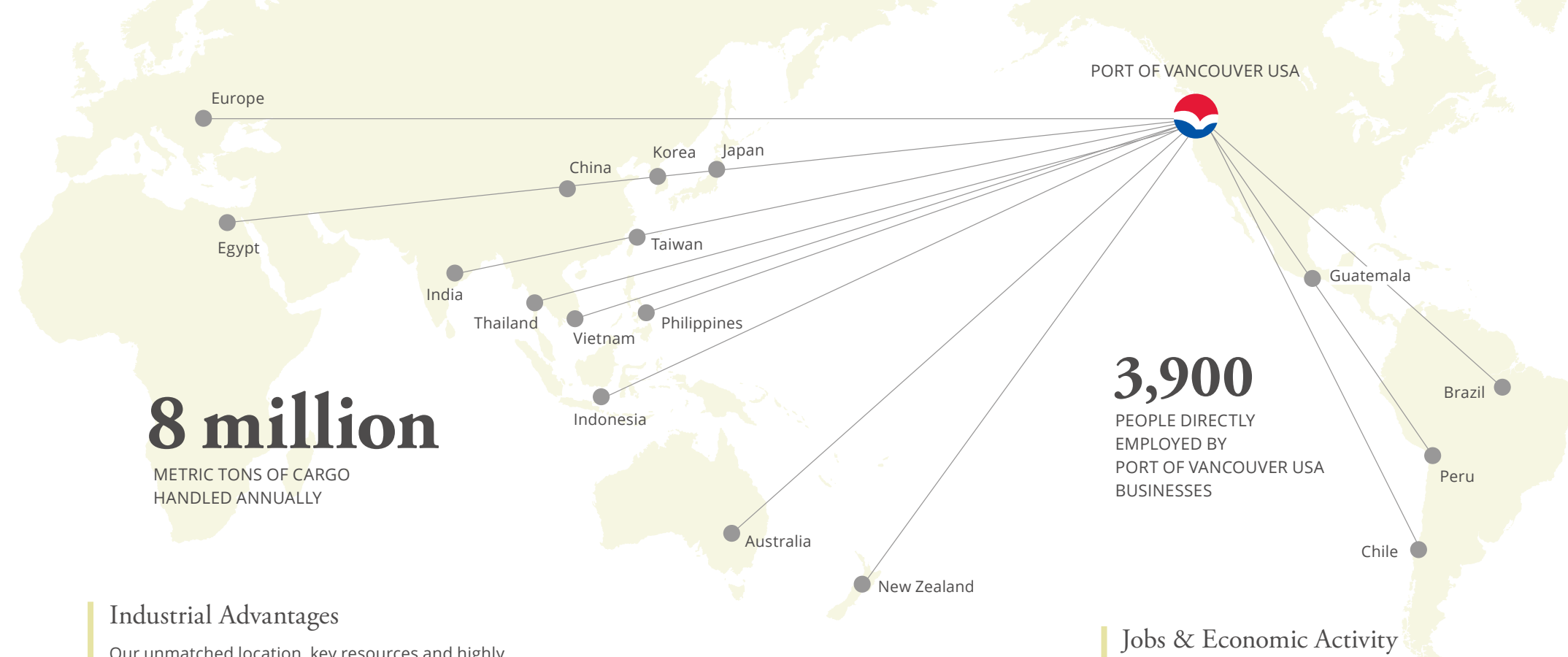

Marine Benefits

Strategically located on the Columbia River, the Port of Vancouver serves as the premier gateway to the United States and Canada.

- Five terminals with 13 shipping berths
- 43-foot, deep-draft shipping channel
- Two 140 metric-ton mobile harbor cranes
- More than 700,000 square feet of waterfront warehousing
- Between 400 and 500 vessel calls annually
- 7 million metric tons of cargo handled annually
- Approximately 80% exports and 20% imports
- Top exports: grain, corn, beans, scrap steel and other bulk materials
- Top imports: steel, dry and liquid bulks, autos
- Top trading partners: China, South Korea, Malaysia, Japan, Australia, Europe and South America



Industrial Advantages

Our unmatched location, key resources and highly skilled workforce make the port an ideal place for businesses to grow and thrive.

- Over 2.5 million square feet of industrial warehousing
- Over 850 acres of developed property for industrial and marine activities
- 11 ready-to-build acres (5 lots) at our Centennial Industrial Park
- 600 acres of land for future development
- Dual rail carrier service (BNSF and Union Pacific), unit train capable
- Easy access to river, road and rail transportation—10 miles to Portland International Airport
- 42 miles of port-owned rail infrastructure

Public Tours

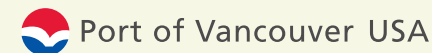
We hold 10 two-hour public tours throughout the year that are free and fun for the whole family. For more information and to make a reservation, call 360-693-3611.

The Port of Vancouver has been governed by a three-person, publicly elected commission since its founding in 1912. Port commissioners Eric LaBrant, Jack Burkman and Don Orange represent port district citizens. They each serve six-year terms and are responsible for setting port policy. Monthly commission meetings are open to the public.
